Call to order: The meeting was called to order by President Becky Riley at 12:45

**Opening Prayer** was led by Pastor Julie Morris.

A Year in Review Slide Show put together by Carina McVeigh

**Approval of January 2022 Annual Meeting Minutes:** Randy Churchill moved to approve the minutes. The motion received a second from Lisa Saner. **The motion passed by a voice vote.** 

**Child Development Center Report** – Amy Vega and Lisa Saner: CDC became their own entity & created handbook; 78 children are enrolled so they are at max capacity; added Spanish, Dance, and Soccer classes; added new (upgraded) playground.

**Pastor's Report** – Pastor Julie thanked the congregation, the staff, her husband, Paul, and recognized outgoing Council member, Kevin Churchill and outgoing President, Becky Riley.

Pastor Julie directed people to her written report in the Annual Report Booklet. She expressed her joy in serving as pastor of Mount Cross, her love for the congregation, and her gratitude for the excellent lay leadership in the congregation. She also shared "Mount Cross Story Corps" stories. She frequently hears that people appreciate that we have one service on Sunday mornings with a variety of music. People are spiritually nourished through our worship services. They see children loved and called forward by name. One frequent visitor commented, "Every Sunday feels like Easter at Mount Cross." She is aware of several stories of gratitude about Mount Cross caring ministries. People who receive care in the form of cards, calls, meals, prayers, or rides to medical appointments often become participants in those caring ministries themselves. She hears from newer members that they are overjoyed to find in Mount Cross and the ELCA an expression of Christianity that is welcoming, centered in God's grace, fully inclusive, and committed to justice. She noted that Mount Cross should not feel immune to the overall cultural decline in church membership. We need to be alert for creative ways to partner in the community. She announced that this year, for the first time, Camarillo United Methodist Church will join with Mount Cross and St. Columba's for Ash Wednesday and Holy Week services. Pastor Julie articulated two

goals for year. First, she wants to work with a team to create an intentional process for welcoming newcomers and preparing them for baptism/affirmation of baptism and church membership. Second, she wants to work with the Care Team to make sure the whole congregation understands itself as part of the Mount Cross caring ministries: "A card, a call, a visit, a meal, a prayer, a ride." She thanked the congregation, the staff, her husband, Paul, and recognized outgoing Council member, Kevin Churchill and outgoing President, Becky Riley.

**Recognition of RIC Sunday** – a video from Bishop Bos was played.

Special Recognition of Rick Mann for his many years of service to the Property Committee

**Treasurer's 2022 Financial Report** – Rick Gardner noted that due to a substantial rise in new members, Mount Cross was in very healthy shape financially.

Balance Sheet for the end of 2022:

Cash assets totaled \$902,822.

Of this amount, the Endowment Fund balance was \$529,862 and dedicated funds were \$179,272. Cash reserves for year-end were calculated as \$134,655.

The mortgage balance is \$224,895. The original balance was \$744,000. Payoff will be in 2034.

### Budget Performance for 2022:

Gross income was \$466,304 (105% of budget).

Pledged giving was \$334,089 (108% of budget).

Expenses were \$497,529 (101.5 % of budget amount of \$490,347).

Net income was \$466,304 - \$497,529 = -\$31,225 (compared to budget amount of - \$47,927).

## Analysis:

- 1. Pledged giving and income were well above budget. Expenses were \$7,000 higher than budget in 2022 (101.5%) due to higher insurance costs, unbudgeted payment of CDC incorporation fees, unplanned installation of a new HVAC system, and higher worship and music costs.
- 2. The annual loss for 2022 was \$31,225 compared to the budgeted loss of \$47,927. Reserves were down by over \$31,000 in keeping with the annual loss. Despite this loss, reserves continue to be in the healthy range above \$100,000.

Rick Gardner presented the 2023 budget recommended by the Church Council for congregational approval. He provided the 2022 Operating Budget and actuals for comparison. The recommended budget consists of a Funded Budget, drawing from operational funds and dedicated funds. Rick also showed the Funded Budget in narrative format with a pie chart highlighting the following ministries: Worship & Music (31% of budget), Learning & Youth (30%), Service & Mission (22%), and Caring (17%).

2023 pledges are at \$357,004, compared to \$309,765 in the 2022 budget. Total income for 2023 is projected at \$499,740. Expenses for the 2023 Funded Budget are estimated as \$562,300, to be funded by \$499,740 in operational funds and \$51,052 in dedicated funds. In addition, we propose to draw \$11,509 from reserves. Expenses for the 2023 Operating Budget total \$511,249 (\$499,740 plus \$11,509 from reserves).

Rick discussed some expense elements from the budget, most notably Salaries and Benefits, which constitute about 2/3 of the budget. He explained Pastor Julie's proposed compensation as well as that of Joe Zimmerly, Director of Children, Youth and Family Ministries. Rick also discussed the growing "meal' ministry, consisting of Tuesday night caring meals for the homebound and Wednesday night meals for the confirmation families and others. Associated with the meals is a new expense account associated with the meal preparer." Rick answered questions:

Question: Did we account for Nat gas increase? - yes

Question: What is current membership? – about 330 (per Pastor Julie) Question: Secretary (62410) is two employees. Should we separate that? That can be done. In fact, it used to be done that way.

Since 1983, the Reconciling in Christ (RIC) Program has been a public way for faith communities to see, name, celebrate, and advocate for people of all sexual orientations, gender identities, and gender expressions in the Lutheran church. Much of the past eighteen months has found Mount Cross engaged in the discernment process of becoming an RIC congregation. As noted in our previous forums, to be recognized as a RIC congregation, we will need to:

- Clearly state a welcome to people of "all sexual orientations, gender identities, and gender expressions" or "LGBTQIA+" and name its commitment to "racial equity" or "anti-racism" in its welcome statement. (Please see our proposed welcome statement on the back of this page).
- Be open to calling an LGBTQIA+ and Black, Brown, Indigenous, Person of Color (BIPOC) Rostered Leader.
- Allow sanctuary or community space to be used for LGBTQIA+ weddings and blessings (which will be consistent with our policies for heterosexual weddings and blessings).
- Make a meaningful contribution annually to support the national RIC program (which we will fulfill from RIC-directed donations).

Eligibility to Vote: According to the Mount Cross Constitution, "Voting members are confirmed members." Such confirmed members, during the current or preceding calendar year, shall have communed in this congregation and shall have made a contribution of record to this congregation."

\*Confirmed members are baptized persons who have been confirmed in this congregation, those who have been received by adult baptism or by transfer as confirmed members from other Lutheran congregations, or baptized persons received by affirmation of faith.

## REPORTS TO THE CONGREGATION

# Pastor: Pastor Julie Morris

Dear Mount Cross Community,

I love being a pastor. I love being *your* pastor. I love walking alongside you as individuals and a community, reminding you that God is with you and for you. I love gathering with you around the Word and Sacraments, celebrating the boundless grace of Christ. I love being a front-row witness to your faith, generosity, and service. I love working with the Dream Team Mount Cross Staff and Executive Committee. There is so much variety and depth to the work I get to do, that it is always a challenge to summarize it. Most of what I do fits into these five categories:

- 1. **Worship.** Worship includes liturgy planning, funerals, seasonal planning, preaching preparation, and special services.
- 2. **Pastoral Care.** Pastoral Care includes pastoral visits to homes, hospitals, care facilities, or appointments in the office, preparing people for baptism and membership, crisis response, Care Team, and caring communications, such as emails, phone calls, cards, and texts.
- 3. **Faith Formation.** Faith Formation includes Bible studies, Rooted, Confirmation class, preschool chapels, the Discipleship Experience, and the Peace & Justice/RIC Team.
- 4. **Administration.** Administration includes staff meetings, staff and volunteer supervision, Church Council, Executive Committee, other committees, Child Development Center Board, calendar and event planning, and writing for reports, newsletters, announcements, evaluations, etc.
- 5. Wider Church and Community. This includes collaboration with other churches, Synod (ELCA) and Diocesan (Episcopal) meetings and service, mentoring clergy in formation, collegium clergy meetings, clergy support group, community engagement, and pastoral care (including weddings and funerals) for people who are not members of the Mount Cross community.

You can read more details about my ministry with you in the monthly Pastor's Reports I submit to the Mount Cross Congregational Council. Here is how I will remember 2023:

#### The Year of the Three Churches.

After decades of joining together with St. Columba's Episcopal Church for Ash Wednesday, in 2023, we welcomed Camarillo United Methodist Church into the collaboration and a spark was ignited! Not only did we worship together for Ash Wednesday, but we held combined Maundy Thursday, Good Friday, and Easter Vigil services. Memorably, on Good Friday, we carried a large cross in a procession beginning at Camarillo UMC, pausing at St. Columba's, and ending at Mount Cross for the Good Friday liturgy. We held three more combined events in the fall of 2023: a Reformation Sunday forum and panel at Camarillo UMC on the future of the church, the Thanksgiving Eve Holden Evening Prayer and Pie Social at Mount Cross, and a "Blue Christmas" service at St. Columba's in December. I expect we will have similar shared services and events in 2024 and that these partnerships will continue to develop.

## The Year of the Prayground.

Worship is for the whole family of God. It's wonderful that this year, the Family Faith Formation Committee implemented dedicated space in our sanctuary to welcome our families with young children. I smile every time I see our Prayground and the little ones in it!

## The Year of Reconciling in Christ (RIC).

On All Saints' Sunday 2023, Mount Cross voted decisively to become a welcoming and affirming congregation to all members of the LGBTQIA+ community. I believe this is a movement of the Holy Spirit in the Church in our times, a recognition of the image of God in every human being, and an expression of the breadth and length and height and depth of Christ's love. The Reconciling in Christ Team, under the leadership of Lyndsay Montour and Becky Gilbertson, gracefully guided the congregation through a thoughtful process of discernment. The educational forums and opportunities for discussion invited honesty and provided space to ask questions and grow in understanding. I commend all members of Mount Cross for engaging the RIC conversation with civility, sincerity, and prayer. We will celebrate our first RIC Sunday the same day as this Annual Meeting, January 28!

### The Year of the Discipleship Experience.

Sixteen adults (and their fourteen children) signed up for an experiment we called "The Discipleship Experience." It is a 9-month commitment to Christian spirituality and community, including daily prayer, weekly worship, monthly gatherings, and service. Participants are growing in their relationships with God, each other, and the congregation. I expect it to continue in some form beyond this pilot program.

## The Year Make, Bake, Celebrate! Returned.

After a three-year hiatus, Patti Stouch and her team resurrected Make, Bake, Celebrate! The spirit of Mount Cross beams at this beautiful evening of generosity and community.

### The Year Four Staff Members (including me) Got COVID at the Same Time.

After three years, COVID caught up to us. Thank God it was mild, but with four of us out of commission, we had to cancel worship at Mount Cross on March 19, 2023. We were extra grateful for our full-communion partners, St. Columba's and Camarillo UMC, for welcoming Mount Cross folks to their services that day.

#### The Year Our Hearts Broke.

There is so much to be thankful for when looking back at 2023, and yet I will remember it also as the year all of our hearts broke because of the losses of Celia Joy Moraga and Jason Soyster in August. There is nowhere to turn in these tragedies except to our faith in God and our love for one another. For the Moraga and Soyster families, and for all who suffered the death of loved ones this year, we pray for comfort and strength.

#### Looking Ahead.

We really cannot know what lies ahead, but we can put our hopes in God's hands, and we can seek God's blessing on our plans. August 1, 2024 will mark the completion of my fifth year at Mount Cross and my eligibility for a three-month sabbatical, which I plan to take in the fall. More details will be shared as they come together.

I hope 2024 at Mount Cross will be **the Year of Invitation and Welcome**, where we step out boldly into our community, inviting people to join us in knowing, loving, and serving our God who loves without limits. No exceptions.

I pray that you may have the power to comprehend, with all the saints, what is the breadth and length and height and depth, and to know the love of Christ that surpasses knowledge, so that you may be filled with all the fullness of God. (Ephesians 3:18-19).

# Deacon: Deacon Dr. Cecelia Travick-Jackson

My duties and responsibilities as an ELCA Deacon are to bridge the gap between congregational ministry and ministry in the wider community. This is not a responsibility that I take lightly. The responsibilities of being a deacon are extremely fulfilling and a gift from God, although there are those days when the words of Mother Teresa ring true," I know God will not give me anything I can't handle. I just wish that He didn't trust me so much."

Following are some of the duties and responsibilities of being your deacon. As you review my report, be cognizant that some of what I do is done away from the physical setting of Mount Cross. This is all a part of bridging the gap between congregational ministry and ministry in the wider community. My call to ministry is Senior Adult Senior Ministry. I have attended and participated in every funeral at Mount Cross during 2023. I also attend funerals at the Synod level whenever possible. I have not been able to visit as many members as I have in the past, but I call parishioners, email them, and make sure that they receive cards from me personally and/or cards from the Senior Adult Ministry.

I have regular responsibilities at Mount Cross. Sunday service is very important for me on a personal and spiritual level. I also appreciate a well-organized, liturgical service. This might be indicative of my age. On Sunday morning, I work to make sure all volunteers are present. If someone is absent, I make sure their role in the service is covered. If someone is in a role that is new to them, I take the time to practice with them and try to make them comfortable in their service to God. I try to make sure Pastor Julie's before-service time is protected so that she may pray and prepare to deliver Jesus' message. In addition, every Sunday we (those participating in the worship service) take time to pray, asking God to strengthen us, guide us, and order our steps to the glory of his holy name.

In addition to regular Sunday worship. Senior Adult Ministry has taken on the responsibility of drive-through Communion. I love this ministry, because it says we are here to offer Christ to you. If you are ill, if you have mobility issues, if you are tired, if you are short on time, or for any other reason you may have, you are welcome to the Lord's table at Mount Cross. Conversation, prayers, the Lord's Supper, and even treats from the hospitality team are available during drive-

through Communion. Something that I especially like is when people bring their pets (usually dogs) and the dogs anxiously await their treat. You can see their little furry heads pop up and they lick their lips in anticipation of their church treat.

The lifting of COVID restrictions has greatly reduced the number of people who come to drivethrough Communion, but for those who do come, this ministry is very important to them. We often receive prayers, cards, and genuine gratitude for this ministry,

When Pastor Julie is away, I serve as the on-call minister. I attend weekly staff meetings and I am involved in additional Mount Cross activities as I am able, such as committee meetings, Ecumenical services with St Columba's and the Methodist Church, special programs, and seminars at church.

My call as deacon also includes the wider church. As Assistant to the Bishop, I attend ordinations, installations, conferences, special meetings, pulpit supply, special committee meetings, planning committees, and in several other ways highlighting the Southwest California Synod. As Assistant to the Bishop for Senior Adult Ministry, this affords me the opportunity to share what we do at Mount Cross and to learn what other churches are doing in their congregations. I am able to offer the churches in our Synod resources, suggestions, support, and other special services. (Our synod is divided into nine (9) conferences, totaling 112-115 congregations.)

I attend Synod staff meetings, theological/educational events, training sessions, Synod deacon gatherings, leadership retreats, special mass services (Chrism Mass), Synod Assembly, Conference Colloquy (we are in the Channel Island Conference), Bishop's Colloquy, and other trainings and meetings as requested, such as "TheOasis," a retreat for clergy and church leaders. Often these meeting and gatherings last more than one day, necessitating travel and an overnight stay.

Moving from the Synodical level to the Churchwide level, I attend meetings and workshops for ELCA deacons. These include monthly book studies, participation in online worship experiences, conferences, Deacon Leadership retreats where I served as a group leader for emerging deacons, and The Rostered Leaders Gathering in Phoenix, where I conducted a workshop this past July.

I continue my work in Glendale, Arizona, as a member of St. John's Lutheran Homes. This is a senior housing facility in Arizona that has a long relationship with California Lutheran Homes in the Southwest California Synod.

Finally, my Diaconate call to Word and Service is bridging the gap between church and world.

## ADULT EDUCATION AND SPIRITUAL FORMATION

Mount Cross offered several adult spiritual formation opportunities in 2023.

- 1. Men's Bible Study met at Marie Callender's at 7:30 a.m. on the first and third Thursday of the month throughout the year to reflect on the upcoming Sunday's Gospel text, facilitated by Pastor Julie once a month and a lay leader once a month. Attendance ranged from 8-16.
- 2. A Women's Bible Study met weekly on Tuesday mornings at 9:00 a.m. in the sanctuary throughout the program year, following the *Gather* magazine studies. During the summer, the group met at various locations for a walk/hike and scripture discussion. The group was facilitated by Pastor Julie or a lay leader. Attendance ranged from 5-12.
- 3. ROOTED, for parents of Fun with Faith children and all adults, met Wednesdays from 5:00–5:45 p.m., outside or in the sanctuary. It was facilitated by Pastor Julie or a lay leader. Attendance ranged from 8-20.
- 4. A weekly Christian Meditation group met on Monday afternoons on Zoom.
- 5. The Lenten Wednesday evening study was called "Life Transformed: The Way of Love in Lent." We were joined by people from St. Columba's Episcopal Church. Pastor Julie, Rev. Mark Asman, and Rev. Susan Klein shared leadership of the study.
- 6. Pastor Julie and Kevin O'Farrell taught a class on Sundays in Lent called "Christianity Through a Lutheran Lens" using Daniel Erlander's *Baptized We Live* booklet.
- 7. Pastor Julie and Kevin and Chrissy O'Farrell shared facilitation of "The Discipleship Experience" for 16 adults (and 14 children). It is a 9-month commitment (September 23-May 24) to Christian spirituality and community, including daily prayer, weekly worship, monthly gatherings, and service.

## **AUDIT COMMITTEE**

In 2023, the Audit Committee undertook an audit of the records of Mount Cross for the calendar year 2022. For the first time in many years, the audit did not include the activities of the Child Development Center as it completed its legal separation from Mount Cross. Members of the Audit Committee were Jim Prosser, Dave Gilbertson, and Tom Carr. The audit was conducted between April and July of 2023 and included a review of the records of the Financial Secretary, Bookkeeper, Church Treasurer, Endowment Fund, and the Pastor's Discretionary Fund. A written audit report was submitted to the Church Council in September. The committee found that there had been a proper accounting of all funds received and expended. The Church Council later approved the audit.

The Committee found that recommendations from the prior year were mostly implemented. The Committee was surprised that our current bank did not offer any high yield savings options and recommended that reserve funds be moved to a financial institution offering higher interest rates. This issue was discussed with the Treasurer early on and resulted in the church setting up a fully-FDIC-insured, money market account earning 5% instead of the .1% available at Citizen's Bank. Finally, the committee again recommended that a CPA firm be engaged to do the audit next year, consistent with guidelines from the ELCA.

## **CARE TEAM**

A little over four years ago, the Care Team was reactivated for the purpose of 1) identifying areas where caring support may be needed; 2) identifying and/or creating caring responses to identified needs; 3) providing support and coordination to other caring efforts of the church; and 4) becoming a recognizable caring resource for the congregation. Since that time, core Care Team committee members and **numerous volunteers** have worked to strengthen caring support for members and friends of Mount Cross. It is important when reviewing the undertakings of this committee that you realize that much of what is accomplished happens thanks to a much broader circle than just the "Team."

## 2023 Regular Care Team Functions:

- Monthly meetings are held to assess congregational needs.
- Year-round **Card Ministry Program** matches **volunteers** with persons/households to maintain regular connection. During holiday periods, additional persons receive cards from Team and **volunteer** members of the church.
- **Sympathy Cards** are sent by **volunteers** on behalf of the congregation along with appropriate CareNotes. Appropriate Christmas cards and CareNotes are also sent to those who lost a loved one during the year.
- The ongoing **Health Ministry Program** offers information and support from our Health Ministry Nurse and access to pertinent materials. Rotating materials are available in the clear "pockets" on the wall of the church narthex and offered monthly on a Sunday resource table. Caring support and referrals during health challenges are offered by volunteer **Health Ministry Nurse Evonne Kuchera**, **RN**.
- Care Bags are filled with items aimed at specifically comforting people during active medical treatment or recovery. They are generally distributed by Pastor Julie but can be requested or recommended for another through the Health Ministry Program, the church office, or any Care Team member.
- Tuesday Meal Support Program provided meal support for members/friends of Mount Cross with medical needs or other life-challenging circumstances. 2022 was the first full year of prepared and packaged meals, asking volunteers to only deliver the meals and visit with those who are receiving. This approach has allowed a wonderful mix of volunteers to participate since picking up the meal(s) for delivery at 5:30 p.m. from the church kitchen seems to work even for some who work during the day. The number of meals delivered per week ranges throughout the year, from 10 to over 20 per week, depending on needs at the time.
- Technology Assistance is offered for those with difficulty with watching livestream worship or connecting to virtual programs offered by the church. Assistance with simple general computer problems can also be provided. The church also has several small, basic laptop computers available for loan to members. In-home assistance is offered or questions can be answered over the phone, as preferred. Other general assistance with completing forms or similar tasks, whether on the computer or otherwise, can be offered, depending on the nature of what is involved.
- Education and Information: This was a year where partner churches together planned or publicized education programs. Mount Cross, through the Care Team, provided information about both short and three-session versions of education in AVOIDING SCAMS. MCLC members attended both educational opportunities. We were happy to complete the MOUNT CROSS CARES brochure and place it in the pew racks as well as include it in every stewardship packet. The Care Team provides helpful Health-related information, along with other caring information, monthly in the church newsletter.
- **Senior Ministry Program Collaboration:** Deacon Cecelia participates fully to share information and ideas with the Care Team regarding needs and programing.

- April Suggested Easter Card mailing list provided to the congregation.
- May Joint session on Avoiding SCAMS presented by the County DA's office at St Columba's.
- **August** Health and Healing Sunday special worship service elements, healthy refreshments, and health information resource table.
- **September** Caring brochures included with stewardship packets. Tuesday Meals made a situational change to food prep procedures.
- October Halloween Cards sent to select members by Care Team member Judy Winters. DA's office 3-day SCAM Prevention Academy. Halloween treat bags sent with Tuesday Meals.
- November Thanksgiving cards signed by congregation members and mailed to select members. Advent calendars mailed to select members and handed out at Afternoon Chapel. Shared information about in-person grief group meetings.
- **December** Christmas cards sent to members with a family member death in 2023 along with holiday grief CareNote and notice of the upcoming Blue Christmas service. Suggested Christmas card mailing list provided to the congregation. Provided support at the Blue Christmas service with a CareNote table.

## **CHILD DEVELOPMENT CENTER (CDC)**

The State of California updated our child care license to add a Toddler Option Program, giving the CDC the availability to serve children ages 18 months to 5 years of age. With the addition of toddlers, we were able to update the nursery with new paint, blinds, changing table, portable sink, flooring, and rugs. We would like to thank Lana Lee, our PreK teacher, for the beautiful mural she painted on the nursery walls and John Colby for his help in updating the nursery room.

The CDC also contributed financially to the new flooring in both Luther Hall and the Parish Life Center, giving the children and staff of the CDC a new workplace.

This past year, we brought in Reptiles, Tawni's Ponies and Petting Zoo, and a Roaring Foam Party for in-house field trips for the children. The look on the children's faces was priceless.

## **ENDOWMENT/LEGACY GIVING**

The Endowment Committee is composed of five voting members of Mount Cross Lutheran Church, elected by the congregation, each of whom serve a three-year term. Current members of the Committee are Mary Goodenough, Barbara Cranfill, Craig Blois, Jim Prosser, and Brian Fisher.

The activities of the Committee are governed by Section 8 of the church by-laws. The main purposes of the Committee are to oversee the management of the assets in the Endowment Fund ("Fund") and to recommend to the Church Council the distribution of the annual income 1 generated by the Fund to support the missions, education, children and young adult ministry, worship and music, and capital projects of the church.

For the past several years, the Fund has been invested with the ELCA Endowment Fund Pooled Trust Ministry Growth Fund (formerly known as "Fund A"). The investment criteria of the Ministry Growth Fund are consistent with the "Investment Strategy and Policy Statement" set out in the church by-laws.

<u>Fund Performance</u>. On January 1, 2023, the value of the Fund was \$518,453.88. Through November 30, 2023<sup>2</sup> the Fund generated income of \$16,536.00, which was reinvested in the Fund. During that same period, the market value of the Fund increased by \$29,771.80. The withdrawal of "income" for distribution in 2023 was \$24,620, leaving an ending balance on November 30 of \$540,141.68.

<u>Income Distributions</u>. Each Spring, the Committee solicits suggestions and applications from church committees, outside Lutheran organizations, and individuals for the distribution of the income from the Fund. The Committee then reviews that information and makes

recommendations to the Church Council regarding a proposed distribution. The Church Council can then accept or reject, in whole or in part, the proposed distribution.

#### Additional Activities of the Committee.

The Committee discussed the possible need for a formal gift policy so that members as well as all other contributors to Mount Cross can understand the rules governing gifts to the church. A proposed "Gift Policy" was prepared by the committee and forwarded to the Church Council to review and take action. The Gift Policy is on the January 2024 agenda of the council.

Also, during 2023, the church received three *unrestricted* exceptional monetary gifts totaling \$210,000. In addition, the church received the proceeds of the Make-Bake-Celebrate fundraiser in the amount of \$21,000. The Church Council requested that the Endowment Committee provide input on how these gifts should be used. After reviewing the needs of the church, including the church's current financial condition and the 2024 proposed budget, the Committee recommended that these funds be used as follows:

## **FAMILY FAITH FORMATION COMMITTEE**

### Highlights from the past year:

- Met at least 10 times in 2022 We aim to meet once a quarter in-person at Yolanda's for fellowship and connection. All other meetings are held via Zoom for accessibility and convenience for our members.
- **Dedicated 2023 planning session** in January 2023 to refresh our vision for children, youth, and family, as well as optimize our FFF Committee ways of working to optimally execute our vision for this critically important ministry.
  - Continued this approach for our 2024 planning on January 7, 2024, where we look ahead to the future (had a great turnout!).
- Supported Joe in his addition/onboarding and transition of Children & Youth staff.
- Strong **connection with CDC Preschool**, with a number of our current or past committee members serving on the CDC Board.

- Supported Joe and Mount Cross staff in their continued focus on safety and faith formation for our Mount Cross youth. Continued with Safe Gatherings (program rolled out in 2020 to maintain our safety training for anyone working with youth and children); many volunteers completed this training in 2023.
- Piloted the Prayground, which received overwhelmingly positive feedback by children, families, and church members; approved by Council to become an official part of the sanctuary space; communicated with Redesign Committee on how the Prayground space may be improved.
- Major events included:

  - Increased family Playdate Sundays to approximately every other month (coordinates with youth/family serving Sundays) – these are planned by a rotational host; held in the church playground, nearby park, or beach.
  - Confirmation and Graduation Sundays.
  - VBS (another successful year!)—see Joe's report for full details.
  - o Movie nights with CDC and Parents' Night Out.
  - O Age-specific dedicated programming: Fun with Faith for preschool through 5th grade, Confirmation for middle school, High School Youth group, plus all family and congregation-wide events too these continue to be well attended and serve a vital need for our broader community.
- Annual review of CYFM Director to support their development.

Our choir has learned new anthems and also shared favorite and lesser-known pieces from our choral library. We were delighted to have Fred Antrim and Kris Dawson join the choir, as well as a friend of Evonne Kuchera's, Rebecca Henry (although serious medical issues have prevented her regular participation). We're also hoping that Randy Churchill and Jennifer Moraga are able to return. Our regular roster is Fred Antrim, Carol Broderick, Kris Dawson, Mary Goodenough, Melissa Henry, Darryl Johnson, Gayle Johnson, Evonne Kuchera, Wendy McClary, Dan Nelson, Susan Prosser Barbara Recker, Becky Riley, Keith Selbrede, and Bill Stoll, with Guy Ervin III as our accompanist, and I'm thankful for their commitment and that they share their gifts in our worship. It's always fun when we have other instrumentalists join in on choir numbers—Justin Thai or Amanda Honda on flute, Jessie Hanevich on guitar, and Sean Harbour on trumpet. It's also wonderful when we have additional singers—Carina McVeigh, Brian and Tiana Stouch (and even Becky Riley's brother visiting for Thanksgiving)—join the choir for worship.

I owe a large debt of gratitude to Melissa Henry, who moved the bell choir repertoire from the file cabinets in the sanctuary loft up to the attic storage and replaced it with the choral library that had been in the attic. Having easier access to materials we are using regularly is a huge help. One project for later this year is to dispose of some of the bell repertoire (pieces for larger ensembles than we are ever likely to have again or secular numbers that would not be used for worship).

Instrumentally, we are blessed by our faithful accompanist, Guy Ervin III, and we had fun celebrating his 83<sup>rd</sup> birthday after worship on August 6, his actual birthday. (Guy has been here for 21 years!) We are also blessed by our other instrumentalists, including Jessie Hanevich, guitar; Jerry Warren, keyboard; Carina McVeigh, guitar; Elliott Ripley on piano for the praise band and several other occasions; 5<sup>th</sup>-grader Kylan Blois joining our high schooler Jeffrey Saner on percussion; and most recently, Amanda Honda on flute. Our regular songleaders lead our worship each week, for both our in-person gathering and for the livestream—Melissa Henry, Gayle Johnson, Evonne Kuchera, Carina McVeigh, Dan Nelson, Barbara Recker, Becky Riley, Brian Stouch, and Tiana Stouch, and occasionally, Keith Selbrede and Jeanne Kuchera-Sikoff.

We are also very blessed to have our amazing worship engineer, Bill Dawson, who juggles the technical sound needs of choir and sometimes praise band downstairs, bell choir in the loft, and songleaders and instrumentalists in the loft, with the help of Justin Thai, our Moorpark interns, Joe Zimmerly, and the wonderful volunteers from our congregation. Thanks to an Endowment grant we just received, a project for this year will be purchasing some new sound equipment to streamline our space in the loft and also replace some equipment that Bill has been graciously letting us use.

We are continuing to build a core repertoire of traditional and contemporary music to enrich our sung prayer and support the scriptures and messages of worship. There is such a wealth of music available, including more songs from *All Creation Sings* and CCLI, with different styles of music appealing to different people.

During our choir and bell choir rehearsals, we make a point of sharing prayer joys and concerns, and last year, we had some significant prayer concerns, especially grieving with the Moraga family at the health struggles and tragic death of beautiful baby Celia Joy, and walking with those with serious medical diagnoses or even just issues that arise as we age.

## PEACE & JUSTICE / RECONCILING IN CHRIST (RIC)

The RIC team initially met in 2022 to begin its research on how to provide information on Reconciling in Christ to our congregation. RIC is part of the ReconcilingWorks program, the independent organization for Lutheran congregations that publicly welcome and affirm LGBTQIA+ people and its work for racial equity.

In 2023, the RIC team met monthly and presented educational and scriptural forums with speaker presentations. Speakers included Bishop Brenda Bos, SW California Synod; Marty Kreman, Holy Trinity Lutheran Church, Thousand Oaks; Professor Peter Carlson, California Lutheran University; and Father Patrick Mullen, Padre Serra Catholic Parish. Also provided was a Matthew Vines video and discussion forum, a general RIC forum, a congregational survey with about 75 members participating, and RIC resources entered and available on the Mount Cross website.

In a special congregational meeting on November 5, with 88 members voting, Mount Cross Lutheran Church voted decisively (84%) to become a Reconciling in Christ congregation. After the vote, the Mount Cross Church Council adopted the following Welcome Statement:

Mount Cross Lutheran Church welcomes, embraces, and affirms all individuals, regardless of race, gender identity or expression, sexual orientation, faith background, physical or mental ability or anything else that may set us apart from each other. We are a Reconciling in Christ (RIC) congregation, one of over 1000 Lutheran communities that intentionally welcome and affirm LGBTQIA+ people and families. We are committed to racial equity and the work of antiracism, celebrating the beautiful tapestry of humanity and fostering an inclusive community that recognizes the inherent worth and dignity of every person. We strive to follow Jesus' way of love, compassion, and justice and invite you to walk this path alongside us. With open hearts and open arms, we welcome you.

Mount Cross registered with ReconcilingWorks. On January 16, 2024, we received word that we are now officially recognized as a Reconciling in Christ (RIC) congregation and listed on their roster.

Thank you for the many contributions from the RIC team members: Bill Stoll, Henry Moraga, and Jessica Easter who are outgoing; new members Rachel Zook-Brimer and Meredith Smith; and continuing members Jim Dinges, Becky Riley, Lyndsay Montour (co-chair) and Becky Gilbertson (co-chair).

Thank you to the Council for initiating the RIC process and to the congregation for their participation and prayers. A special thanks to Pastor Julie for her leadership and spiritual guidance. Peace, blessings, and prayers for Mount Cross as we are called to live out this commitment.

Those of us who have served the Property Committee have enjoyed the privilege of supporting the ministries of Mount Cross. In the past year, membership of the Committee was unchanged:

Our congregation has been generous in its support of improvement and maintenance projects on our campus. We extend our thanks to everyone and for the welcome leadership of the Church Council.

In 2022, the Church Council asked the Property Committee to gather cost information and make recommendations to address four of the top five ranked projects on the Ad Hoc Facilities Committee list of priorities. Through 2023, we made progress:

- Sanctuary Exterior Maintenance; the troublesome plastered slopes were covered with tile roofing
- Front Yard Landscaping; pending funding, progress was limited to broad planning
- Parking Lot Condition; cracks were filled, the lot was sealed and re-striped, including legal paths of travel for the handicapped
- Pavilion Enhancements; progress was made on identifying specific improvements and solutions

## **Looking Ahead: Status of Larger Projects**

Decisions of the Endowment Committee and the Church Council in November and December of 2023 will make available funding for an ambitious agenda of significant work in 2024. We want to express our gratitude to those who have made substantial gifts behind this funding.

<u>Re-Landscape of the "Front Yard</u>" between Luther Hall, the office and the street has been discussed at some length. We will go forward this spring with a design proposal and budget for the Church Council to consider.

<u>Pavilion Enhancements</u>: We expect to put before the Church Council a package of specific improvements and a budget for them by mid-year. To accomplish that, more detail of requirements will be required.

Removal of Overgrown Trees in the Playground: Proposals from tree services are in hand and the lowest cost quote will be accepted. Work will be scheduled around activities of the Child Development Center, worship, and congregational events.

<u>Resurfacing Exterior Stairway to Bell Loft</u>: The unsightly, dangerous, and leaky deck material will be replaced. Traction will be enhanced and the troublesome drain will be improved. No more rain in the chair storage closet.

<u>Replacement of Exterior Sacristy Door</u>: As soon as possible, the rusty and balky door will be replaced with a new steel door.

<u>Kitchen Improvements</u>: Other groups will have a say in the particulars of sprucing up the kitchen. The Property Committee will focus on the problem of poor wastewater flow to the sewer.

## **On-Going Maintenance and Repair**

Innumerable small projects were accomplished during 2023 by the remarkable volunteers of the church and the Property Committee members. An obvious trade-off plays out between the work of our volunteers and the expense of maintaining the church. Your time and skills are always welcome. We maintain a lengthy list of maintenance and repair tasks. We, as a committee and the congregation, are deeply grateful to everyone who has contributed time, expertise, and some perspiration to the campus.

All members of the congregation are welcome to attend any Property Committee meetings and to let us know of problems that need care or to offer assistance.

As Chair, this is my opportunity to thank fellow members of the Property Committee for their gifts of time and thought to Mount Cross during 2023. It has been an honor to work with you.

We look forward to more progress in 2024.

#### **SENIOR ADULT MINISTRY**

It is always a joy to share with you the stories, hopes, and dreams for Senior Adult Ministry at Mount Cross. This past year was particularly exciting and gratifying as we heard comments such as "this is my favorite worship service," "I love coming to this service," "I'm so glad I can sit through the entire service," "The snacks are always delicious," and "I just love the fellowship time that we spend together." Comments such as these really warm the hearts of those of us who work to make this ministry a reality. Thank you to those of you who attend Afternoon Chapel every month (the third Thursday) and especially to our dedicated committee members, Randy Churchill, Sonja Demeter, Allison Johnson, Evonne Kuchera, Susan Prosser, Lajean Wenzel, and our newest committee member, Vicky Edell.

In 2023, we took a deeper look at the Mount Cross Mission Statement "Rooted in God's grace, we joyfully witness and serve," and we continue to explore how our church mission is also rooted in senior adult ministry.

Senior Adult Ministry seeks to accommodate the needs of seniors by continuing to provide drive-through Communion every Sunday from 11:00 to 11:15 a.m. to those who want communion, prayer and fellowship. Those who attend drive-through Communion attend for any number of reasons (not feeling well, uncomfortable to sit through an entire worship service, trouble hearing in a large group, vision problems, and other personal reasons). Senior Adult Ministry is there to serve them, and, yes, we also serve and pray for their pets.

We encourage seniors with limited vision to bring and use their iPads, so that they can follow and participate in the order of service. We are able to accommodate a limited number of members who are visually impaired at our Afternoon Chapel service. We are hoping to accommodate more Afternoon Chapel worshippers who are visually impaired as the need arises, with both the technology and technical assistance.

In 2024, we are seeking additional ways to offer worship service. We are exploring offering an Afternoon Chapel Worship Service on some Sunday afternoons. This would not happen every Sunday, and it would in no way distract or take away from the regular 9:30 am worship service. This periodic Sunday afternoon worship service would be in addition to the regular Sunday worship service. The Sunday Afternoon Chapel service would be in addition to the regular monthly Thursday afternoon chapel service.

We are striving to offer one social event per quarter, such as our car theme dinner, bar-b-q and bingo, mocktail party. The social events that we have done in the past were offered once a year. We are now hoping to offer these social events about four times a year, so seniors can get together, socialize, and just have fun.

We are also exploring Gathering at the Table, loosely based on Martin Luther's table talk, where after a meal, we sit around the table and just talk on a particular theme or subject. As seniors, there are a whole host of topics we can freely speak on, such as growing up in the 40's, 50's, 60's, etc.; my first job was ...; Some of you might even decide to be a speaker; Let's record our history; Talk about a favorite Bible verse, etc., etc. The topic possibilities are endless and the conversations stimulating.

This year, Senior Adult Ministry would like to invest in lapel microphones. Standing mics are good, but they limit the mobility of the speaker, also the microphone stand itself can be potentially dangerous to persons with limited vision and/or limited mobility.

2023 was a year of reflection and renewal. We looked at the Mount Cross Mission Statement. We evaluated what we have done, and how we might expand this ministry to fill the gaps for our senior adult population, accommodate the needs of seniors, and provide additional opportunities for seniors to worship and serve.

#### **SERVICE & MISSIONS**

As 2024 begins, we look back on the many opportunities for service in our community and the greater world that your Service & Missions Committee and you were part of!

We supported the "Souper Bowl of Caring" fundraising effort on the church patio on Super Bowl Sunday. We collected funds for the two teams and the "commercials" for ELCA World Hunger—I think the commercials won again. The food items were added to the ongoing collection for the St. Columba's pantry. In March, Mount Cross had a team in the "40th Annual Camarillo CROP Hunger Walk" hosted at Padre Serra Parish. We honored long-time volunteers John and Bev Pearson from St Columba's. Five local hunger agencies were supported in Camarillo.

In April, we lifted up Earth Day, suggesting folks "Make Every Day Earth Day" and finding a place to clean up: a beach, a canyon, or a street!

We installed a "Little Lending Library" by the office to share books in the neighborhood. Many hands were busy sewing the backpack parts into the stylish bags we use. Collections for the items for Lutheran World Relief school kit and personal care kits started with the summer VBS program. In September and early October, we gathered volunteers to string the ropes for the backpacks!! In late October, we again hosted the LWR Ingathering Day—which meant a large truck arrived onsite and local churches brought their LWR quilts and kits to be taken to the warehouse.

In October and November, we asked for donations to go to Lutheran Disaster Relief for the Maui fires and other global disasters. In December, our "Gifts of Hope" alternative Christmas gift program also went to support LDR's work around the world.

We continued the Many Meals participation at St. Mary Magdalen Catholic Parish. Our annual Christmas party for the Oak Place care facility was a success with the clients receiving gift cards, new warm socks, and a "Pizza Party" in mid-December. The Mount Cross Team was also honored with a plaque for the 32 years of this ministry (now hung up in the church office), and we had a nice picture in the newsletter.

Throughout the year, we lifted up other opportunities for individuals to reach out to help the community by making a blood donation, ongoing food collections for St. Columba's food pantry, making lunches for Harbor House food programs, and lifting up advocacy issues.

We worked with the RIC Group to help answer questions and inform the congregation about RIC, and helped with several speaker events throughout the year.

Thanks to the committee members: Bob Boyer, Bill Stoll, Mary Goodenough, Kevin O'Farrell, Becky Riley (Council representative), and Melissa Henry. Additionally, thanks to Barbara Cranfill for help with St. Columba's food donation delivery. If you are interested in getting more involved, please contact one of us.

All of these accomplishments were only possible because of the continued generous support of the Mount Cross family. Thank you for your faith in our team and missions!
