# • Current statement:

Mount Cross Lutheran Church welcomes, embraces, and affirms all individuals, regardless of race, gender identity or expression, sexual orientation, faith background, physical or mental ability, or anything else that may set us apart from each other. We are a Reconciling in Christ (RIC) congregation, one of over 1000 Lutheran communities that intentionally welcome and affirm LGBTQIA+ people and families. We are committed to racial equality, celebrating the beautiful tapestry of humanity, and fostering an inclusive community that recognizes the inherent worth and dignity of every person. We strive to follow Jesus' way of love, compassion, and justice and invite you to walk this path alongside us. With open hearts and open arms, we welcome you.

- The proposed change is in the third sentence which would then read: "We are committed to racial equity and the work of anti-racism..."
- Reason for the proposed change is the following e-mail from Aubrey Thonvold, the Executive Director of Reconciling Works:

"Thank you for sharing your welcome statement. It is a great start. However, after reviewing it, I did not see the needed language Reconciling Works requires in our RIC Partner Public Commitments naming a commitment to anti-racism or racial equality. You can find all four of the commitments <u>HERE</u>. Once the welcome statement meets the requirements, you will fill out the <u>RIC Profile Survey</u> which will start the official welcome process in our office.

As you and your community work to make those updates, please let me know if there is anything I or our program coordinator, David Rask Behling, who is included in this email can do for you."

- The four required commitments, which seem to be satisfied by this minor tweak, are: To be recognized as a Reconciling in Christ (RIC) Partner, your faith community will:
  - Clearly state a welcome to people of "all sexual orientations, gender identities, and gender expressions" or "LGBTQIA+" and name its commitment to "racial equity" or "anti-racism" in its welcome statement.

# **Treasurer's Report**

Budget Performance (through November 2023):

Gross income for November was \$29,723 (71% of budget versus 108% last month).

Gross income YTD was \$409,102 (89% of budget versus 92% last month).

Pledged giving for November was \$21,436 (72% of budget).

Pledged giving YTD was \$314,991 (96% of budget).

Expenses for November were \$39,219 (92% of budget versus 94% last month).

Expenses YTD were \$470,519 (100% of budget versus 101% last month).

Net income for November was \$29,723 - \$39,219 = - \$9,496 (compared to budget amount of - \$967).

Net income YTD was \$409,102 - \$470,519 = - \$61,417 (compared to budget amount of - \$10,642).

Calculated reserves were \$70,651 compared to \$83,915 in October.

# Analysis:

- 1. There was a sharp drop-off in income in November in contrast to above-budget performance in October and near-budget performance in November 2022. The pledged amount was only 72% of budget, the worst performance we've had since February.
- 2. Expenditures were lower than budget for the second straight month. For the year, expenditures are running almost exactly on budget.
- 3. Reserves dropped to below \$71,000. In December, we should see a rebound in reserves due to higher holiday giving. If giving is down for the month, we may be seeing a disturbing trend going into the new budget year.

# **Pastor's Report - Church Council Meeting**

\*Helpers needed for Thanksgiving Eve Set-Up\*

As we gather for our monthly meeting just a few days before Thanksgiving, I am feeling deeply grateful for the whole Mount Cross community, especially our staff, council members, and the many people who serve so consistently and generously throughout the year. I am looking forward to Wednesday night's Thanksgiving Eve service when we will join together to praise God. Jennifer Caldwell, Food Share's Chief Development Officer, will give the message. This year, we are welcoming Camarillo United Methodist Church and St. Columba's Episcopal Church to the venerable Holden Evening Prayer and Pie Social tradition.

It is wonderful to see how the relationship among our **three churches** is growing. The Reformation Sunday symposium on the future of the church drew over 100 people from our three congregations and from the wider community. In December, we will join together for Blue Christmas, and we are already planning for Ash Wednesday and Holy Week 2024. A **Blue Christmas** service is for those who are carrying grief, loss, sadness, or depression during the holiday season. It will be held on Sunday, December 17 at 4 p.m. at St. Columba's. There will be space within the service for people to remember loved ones who have died and to be with others who may be struggling to find hope and joy in the holiday season.

I am thankful for the careful work of the Reconciling in Christ (RIC) team leading up to the important vote on November 5. I am also thankful for the love and grace members have shown one another following the vote. It is now up to each of us to truly embody the all-inclusive welcome we profess. I am energized by this mandate and plan to prioritize community engagement focused on inviting and welcoming newcomers in 2024.

Reviewing my calendar for this past month generates another big dose of gratitude for the variety of opportunities and experiences I have to work with different ages (Rooted, The Discipleship Experience, Women's Bible Study, Men's Bible Study, Confirmation, Pre-school Chapel), stay connected to a variety of Committees and Teams (at least 2-4 different ones each week), interact with the ecumenical and interfaith communities (Feast of Faiths with VCIC and collaborations with the three churches), offer spiritual care (hospital calls, home visits, pastoral care meetings, intercessory prayer); lead the congregation in worship (Sunday word and sacrament); and contribute to the wider church as a mentor/coach to clergy through the Thriving in Ministry program.

I will be away on vacation November 23-30 and December 25-January 3. Pastor Scott Maxwell-Doherty will preach and preside on November 26 and preside over Lessons and Carols and Eucharist on December 31. Deacon Cecelia and local pastors will be available to respond to pastoral emergencies.

For continuing education, I will attend a CREDO conference in Oakhurst, California April 16-22, 2024. It is sponsored by the Episcopal Church to address several dimensions of clergy wellness, including financial, vocational, spiritual, physical, and psychological health.

My five-year anniversary at Mount Cross will be August 1, 2024 (wow – 5 years!). I will be eligible for a 3-month sabbatical. I'm beginning to work with the Executive Committee to plan for that, likely mid-August to mid-November 2024.

Net income for October was \$44,773 - \$40,199 = \$4,574 (compared to budget amount of - \$967).

Net income YTD was \$381,943 - \$430,096 = -\$48,153 (compared to budget amount of - \$9,675).

Calculated reserves were \$83,915 compared to \$84,032 in September.

# Analysis:

- 1. Gross income in October was above budget for the first time in a few months. Expenditures were below budget because October was a two-paycheck month. The net result was a positive income for October, which unfortunately was offset by a restatement of financial results for September.
- 2. Reserves were unchanged from the calculation of the previous month. At the current rate, we will end the year at \$75,000 in reserves, an improvement from our projection last month. We may see further improvement during the last two months of the year.

# Analysis:

- 1. The decline in our operating finances continued in September with below-budget performance in pledged giving and gross income and expenditures that were above budget. The increase in expenditures was due to a three-paycheck month in September and to one-time expenses such as the synod leadership conference (which will be transferred to dedicated funds) and the digital subscription for ICON CMO.
- 2. The result was a net loss for the month of over \$12,000 and an equivalent drop in reserves down to \$84,000. At this rate, we will end the year below \$70,000 in reserves, compared to \$132,000 at the beginning of the year.

# Pastor's Report for September 2023 Council Meeting (August 15-September 13, 2023)

We begin our new program year with heavy hearts, still aching with the Moraga family over their loss of baby Celia and Pastor John Soyster's family over their loss of Jason. Mount Cross has truly lived up to our calling to weep with those who weep and to help bear one another's burdens. Thank you for your prayers, support and generosity towards these families. Celia's Celebration of Life will be Saturday, September 16 at 2 p.m.

I met with Pastor Jade Ortiz of Redimidos/Our Saviour's Lutheran, Oxnard. They are the hosts of the monthly Graceful Diaper pantry. Mount Cross will sponsor the February 2024 distribution. More details are forthcoming.

It's a challenge to report on, let alone attend, all the Mount Cross committee meetings, but this month I have been working most closely with Stewardship, Re-imagining, and RIC. I am always

thankful for the skills and gifts of wisdom and leadership we are blessed with in our congregation.

This past month, we hosted Lincoln Mayorga's memorial service (August 19) and celebrated Michael Hondas baptism (September 3). I was able to have a few meetings reconnecting with members I haven't been able to sit down with in awhile, but never as many as I would like.

I attended chapel at CLU on Thursday, October 7 and met with Pastor Elbert Kim and Dr. Bill Garlington of Camarillo UMC and Mark Asman of St. Columba's Episcopal along with The Rev. Dr. Colleen Dr. Windham-Hughes, Associate Vice-President for Mission and Identity. She will be the speaker at our tri-church forum on Reformation Sunday. I have committed Mount Cross to bringing at least 20 people to that forum (see below). I especially hope Church Council members will register, as I think this will help us understand the context in which we are doing ministry and connect with our full-communion partners.

Is Religion Dying? The Future of Christianity and the Church. Concerns about the decline of mainline Christianity have intensified since the COVID-19 pandemic. Locally, we are observing signs of hope and signs of decline. In an effort to foster faithful conversations within and among our congregations, three churches are joining together to present a forum this Reformation Sunday, October 29, 2023 at 4 p.m. at Camarillo United Methodist Church. Join Camarillo United Methodist, St. Columba's Episcopal and Mount Cross Lutheran as we share a meal together, hear from Dr. Colleen Windham-Hughes, Associate Vice-President of Mission and Identity at California Lutheran University, and discuss our experiences and questions. I will be speaking at an interfaith forum Tuesday, September 26 at 7 p.m. The theme is "Wedding Rituals in Various Faith Traditions." # **Treasurer's Report**

- Budget Performance (through August 2023):
- Gross income for August was \$36,417 (87% of budget versus 88% last month).
- Gross income YTD was \$306,587 (92% of budget versus 94% last month).
- Pledged giving for August was \$28,088 (94% of budget versus 91% last month).
- Pledged giving YTD was \$240,056 (101% of budget versus 99% last month).
- Expenses for August were \$39,376 (92% of budget versus 103% last month).
- Expenses YTD were \$342,253 (100% of budget versus 102% last month).
- Net income for August was \$36,417 \$39,376 = -\$2,959 (compared to budget amount of \$967).
- Net income YTD was \$306,587 \$342,253 = -\$35,666 (compared to budget amount of -\$7,740).
- Calculated reserves were \$96,503 compared to \$103,569 in July.

# Analysis:

- 1. The summer swoon continued in August with pledged giving and gross income falling below budget. Expenses for the month were also below budget, but we experienced a net loss for the month of \$3,000.
- 2. As projected, operating reserves fell below our desired level of \$100,000 in August. Reserves will probably be below \$80,000 by the end of the year. The reserve calculation does not include the recent gifts of \$210,000, even though the donors have not designated the funds for a specific use; these funds are sitting in a temporary holding account awaiting further disposition.

Pastor's Report for August 15, 2023 Church Council Meeting

I was away the first week of this reporting period, enjoying good time with family and friends, including birthdays for two of our daughters. Paul and I have entered a new era of parenting. It's hard to believe we are now officially parents of three young adults, as our youngest daughter turned eighteen at the end of July. Many thanks to The Rev. # Joe Zimmerly August 2023 - Council Report

On July 24th, our middle and high school youth were invited to join Holy Trinity Lutheran Church for a day at Six Flags! Because of their hard work fundraising at Easter Breakfast, they were rewarded with a free trip. We had 2 adults and 4 youth attend from Mount Cross.

After three weeks of fundraising, we raised over \$500 towards Children's Hospital Los Angeles. The donation was written in honor of Celia Joy Moraga, our most recently baptized baby at Mount Cross.

Vacation Bible School was a wonderful time! We had 75 kids attend this year and over 25 volunteers. Our theme was Operation Restoration and our daily themes were Feed, Pray, Heal, Forgive, Rest. We partnered with St. Columba's and their food ministry raising over 700 canned food/non-perishable items which meant Joe and Pastor Julie were dunked in the dunk tank on Friday. Tuesday was our Zander's Game House night where we had 11 people attend. Wednesday was our Topper's Pizza fundraiser night where over 40 people gathered and raised \$320 for our youth programs. Thursday was our VBS Program where our kids highlighted what they had learned all week. Afterwards we enjoyed a cookie and ice cream social under the pavilion. Expenses YTD were \$302,969 (102% of budget versus 101% last month).

Calculated reserves were \$103,569 compared to \$111,492 in June.

# Analysis:

- 1. Our finances in July were subject to the typical summer swoon with pledged giving and gross income falling below budget. Expenses for the month were below budget in most accounts, but this was more than offset by a huge, unexpected increase in the cost of earthquake insurance.
- 2. We ended the month with a loss of over \$7,000 dropping our reserves below \$104,000. We will likely fall below our desired reserves of \$100,000 within the next month.
- 3. The recent gifts totaling \$210,000 have been placed in a temporary holding account awaiting further disposition.

"This is the proposed revised Personnel Handbook Vacation leave language as drafted by the Personnel Committee and endorsed by the Executive Committee of Council (New language in BOLD):"

"Vacation Leave. Mount Cross grants ten (10) days paid vacation to full-time employees working 1-5 years. After 5 years of employment, full-time employees will earn one additional day of paid vacation for each year of service up to a maximum of 15 days' vacation. The vacation benefit for an exempt employee may be modified from the foregoing so long as the modification is in writing, signed by the employee and approved by the Church Council. Mount Cross grants to any part-time employee who regularly works more than 30 hours per work week five (5) paid vacation days at their regular rate of pay for the number of hours that would normally have been worked. Vacation accrual begins upon employment in a position eligible for vacation benefits and is earned pro- rata from their start date. For example, an employee starting on July 1, would be eligible for one half the normal vacation time earned for their credited experience. Overtime hours are not included in the basis for calculating vacation accrual. Vacation must be scheduled at a time appropriate to the planning of the organization and approved in advance by the Senior Pastor.

- Vacation may not be taken during your first six months of continuous employment. Vacation leave may not be taken until it is earned.
- The Church urges employees to take their vacation annually. Once an employee accrues 150% of the annual allotted vacation, accrual of vacation stops. For instance, an employee entitled to ten (10) days of vacation who accrues fifteen (15) days of vacation will cease accruing additional vacation until his or her vacation balance falls below the fifteen (15) day cap in years 1-5.

Upon termination of employment, employees will be paid for accrued vacation time and current unused vacation time prorated based upon the employee's termination date."

NOTE: In response to the Council Motion of June, the Personnel Committee is not recommending a change in Vacation Leave policy for full-time non-exempt staff at this time.

# Motion Monday, July 24th

The Personnel Committee has made a motion to approve the below modification of employee vacation leave accrual for Joe Zimmerly. The Council voted electronically via email.

"Modification of Employee Vacation Leave Accrual

On July 18, 2023, the Church Council of Mount Cross Lutheran Church added the following language to the Employee Handbook concerning vacation accrual: "The vacation benefit for an exempt employee may be modified from the foregoing so long as the modification is in writing, signed by the employee and approved by the Church Council."

The basic Employee Handbook provision regarding vacation leave accrual is 2 weeks of vacation leave in the first 5 years of employment. Joe Zimmerly is employed as the Director of Children Youth and Family Ministries at Mount Cross, which is a full-time, exempt position. It is the desire of the Church Council to provide for 3 weeks of vacation leave (15 days) annually for Joe Zimmerly (`'the Employee"), effective January 1, 2023. Thus, the vacation accrual rate for the Employee shall be 4.62 hours per pay period as of the first payroll period in January, 2023. Since the accrual rate for the Employee prior to the Council action on July 18 was 3.08 hours per pay period, there shall be an adjustment of 1.54 hours for each completed payroll period as of this date, and going forward the vacation accrual rate shall be 4.62 hours per pay period. All provisions of the Employee Handbook

In services at Mount Cross, we commended Bob Winters (June 23) and Debra Kolibas (July 18) to the loving arms of God and extended our care and support to their families.

In addition to more need-based pastoral care, I am making a special effort this summer to have at least a few meetings each month just to get to know church members better or to connect with people who have not returned since COVID. Please let me know if there are particular people you would like me to meet with or call.

Knowing of Mount Cross' commitment to the community, Camarillo Chief of Police Eric Tennessen and Camarillo City Manager Greg Ramirez invited me to lunch to discuss homelessness in Camarillo on June 27. The RIC team received 75 responses to the survey on the sample RIC welcome statement. We found that many were wholeheartedly supportive of this statement. The survey also identified the need for more scriptural and/or educational engagement. The breakdown of responses is included below.

- 10 YES, need either more scriptural or educational engagement or both
- 2 NO, need more scriptural engagement
- 13 NO

July 2023 - Council Report

On June 26th, I took two of our high schoolers on a tour at Cal Lutheran. We were there for a few hours and even had their parents attend too. It is so important that our kids know about our Lutheran colleges, especially if they happen to be twenty minutes away.

I was away at the Western States Youth Gathering from July 3-9 serving as the Night Life & Community Life Coordinator. On July 6, our two high schoolers arrived, as well as our chaperone for the weekend. I can say that our kids left feeling Revived, Reunited, and Rejoiced. Did I mention we had a foam party too?

On July 24th, our middle and high school youth have been invited to join Holy Trinity Lutheran Church for a day at Six Flags!

Our first Sunday selling Lemonade was a success! We raised \$289 towards Children's Hospital Los Angeles. We will continue raising money by selling Lemonade for two more Sundays. Jennifer Moraga talked to our kids explaining what the money could go towards at the hospital. For perspective, we raised enough money to feed over 50 people at the hospital.

#### **Treasurer's Report**

Budget Performance (through June 2023):

- Gross income for June was \$40,863 (98% of budget versus 82% last month).
- Gross income YTD was \$238,074 (95% of budget versus 95% last month).
- Pledged giving for June was \$25,127 (84% of budget versus 87% last month).
- Pledged giving YTD was \$179,540 (101% of budget versus 104% last month).
- Expenses for June were \$37,757 (89% of budget versus 117% last month).
- Expenses YTD were \$258,751 (101% of budget versus 104% last month).
- Net income for June was \$40,863 \$37,757 = \$3,106 (compared to budget amount of -\$967).

- Net income YTD was \$238,074 \$258,751 = -\$20,677 (compared to budget amount of -\$5,805).
- Calculated reserves were \$111,492 compared to \$108,400 in May.

# Analysis:

- 1. Our finances in June out-performed the usual summer swoon with a gross income close to budget and expenses under budget. The decrease in expenses was primarily due to a two-paycheck month for staff. The result was a net income of \$3,106 for the month and a corresponding increase in reserves to \$111,492. Nevertheless, we still appear on track to drop below our desired reserves of \$100,000 by late summer or early autumn.
- 2. We have been blessed by the generosity of church members over the past couple of months. We have received \$110,000 in gifts with another \$100,000 due this week. The donors have provided no stipulations as to the use of the funds other than to put it to the best use for the church.

I consider it a sacred privilege to offer pastoral care to people at the end of their lives and to accompany families as they release their loved ones into God's care. - I enjoyed Synod Assembly June 2-3 at CLU with a focus on ministry among people with disabilities. Mount Cross was well-represented by delegates Allison Johnson, Vicky Edell, and Kevin O'Farrell. Allison presented a summary of the Assembly as an announcement at worship on June 4.
- It was fun to work alongside the Property Committee and others at the work day on Saturday, June 10. Thank you to all those who do so much unseen service to make our property functional and beautiful!
- I am working with Chrissy and Kevin O'Farrell to design a one-year intentional Christian formation and discipleship experience. We will pilot the program with Faith Formation families from September 2023 May 2024 in the hope that it will become an annual offering at Mount Cross.
- I was at Virginia Theological School in Alexandria, Virginia for a Thriving in Ministry training June 12-18. I was trained to serve as a mentor/coach to clergy using a model that focuses on 8 areas of clergy growth: building internal connections; growing collaborative leadership; connecting gospel to culture and context; increasing conflict adeptness; strengthening spiritual practices; setting and managing clear goals; increasing community engagement; and advocating and bridging gaps with those on the margins. # Joe Zimmerly June 2023 - Council Report

As we continue to pilot the Prayground area throughout the summer, we wanted to share with you the recent configuration changes we have made to the area. A picture and notes of the changes made are on the next page.

Venmo has been a great tool and has been meeting families needs. We have seen our account become very active! When we created the account, Venmo created a personal account and a business account for us. We have been using the personal account since the beginning, but can't seem to find out why we have the business account. With a few donations going through the business account, it has made recording a little difficult for the Financial Secretary as the only access to said account is through the app. With that said, VANCO (our long-time church giving platform) has released an updated digital giving platform. Many features were not offered in our initial conversations of Venmo vs. VANCO. In hopes that Make Bake Celebrate explores the effectiveness of VANCO's new service being offered for their event, we hope they will provide adequate feedback in which we can take into consideration how we might use it in our programs. What this means is that we want to properly align our giving to meet the needs of families, streamlining the recording process, and meeting the needs of the financial secretary and if that means VANCO is easier to record than Venmo, we will need to greatly consider the utilization of both programs.



# **Treasurer's Report**

# Budget Performance (through May 2023):

Gross income for May was \$34,308 (82% of budget versus 119% last month).

Gross income YTD was \$197,211 (95% of budget versus 99% last month).

Pledged giving for May was \$25,801 (87% of budget versus 127% last month).

Pledged giving YTD was \$154,413 (104% of budget versus 108% last month).

Expenses for May were \$49,681 (117% of budget versus 99% last month).

Expenses YTD were \$220,979 (104% of budget versus 100% last month).

Net income for May was \$34,308 - \$49,681 = -\$15,373 (compared to budget amount of -\$967).

Net income YTD was \$197,211 - \$220,979 = -\$23,768 (compared to budget amount of -\$4,837).

Calculated reserves were \$108,400 compared to \$125,874 in April.

#### Analysis:

- 1. After an excellent financial performance in April (due in large part to Easter giving), we have turned sharply downward. Pledged giving and gross income in May were down, and expenses were up. The net result was a loss of \$15,373 for the month and a drop in reserves to \$108,400.
- 2. The increase in expenses was primarily due to insurance payments; we paid over half of our annual insurance billings in May (year-to-date, we have paid over 75%). Also, in May there was an adjustment in the pastor's pension to make up for under-billings by the Episcopal diocese during the first few months of the year (we called their attention to this).
- 3. As projected, we will drop below our desired reserves of \$100,000 this summer, perhaps in one month from now. At the current rate of decline in reserves, we will finish out the year below \$75,000.

In addition to regular ministry, including worship planning, preaching, pastoral care, Bible studies, preschool chapel, staff supervision, and committee meetings, here are some things that come to mind as I reflect on the past month and look towards the summer.

Sincere thanks to Marilyn Gardner!

Marilyn Gardner recently retired from her role as Coordinator of the Helping Hands Ministry. She has served in that role for as long as I have been at Mount Cross, and I'm sure for many years prior! Countless families have been comforted by her and her team's efforts to coordinate receptions following funeral services at Mount Cross. Thank you and God bless you, Marilyn! As we look for a replacement for Marilyn, I am grateful to those who are willing to help at the upcoming service for Nancy Jaeger (May 18).

## Clergy Conference

I attended the Episcopal Clergy Conference in Riverside May 1-3. The theme was "Moving forward as Beloved Community: Lament, Hope, Communion." It was a good opportunity to connect with my Episcopal colleagues. I was able to share about our recent collaborations for Lent and Holy Week with our full communion partner churches. Many large and small group discussions during the conference focused on the need for all congregations to be creative in addressing declining membership, insufficient staffing, and limited financial resources.

## Diaper Pantry

Redimidos is an ELCA worshipping community that meets at Our Savior Lutheran Church in Oxnard. Redimidos sponsors Graceful Diapers, a monthly diaper pantry for low-income neighbors. I volunteered there on May 6 and was moved to see the extreme need of families, many of whom began lining up nearly two hours before the distribution began, for a pack of 25 diapers. God bless the Pastor of Redimidos, Jade Ortiz, and their youth group and other volunteers who serve the community this way each month. They are in need of additional sponsors for the diaper pantry. I hope Mount Cross can commit diapers and volunteers for 2-3 months each year.

#### **Treasurer's Report**

Treasurer's Report – 5/16/2023

Budget Performance (through April 2023):

- Gross income for April was \$49,422 (119% of budget versus 84% last month).
- Gross income YTD was \$164,685 (99% of budget versus 92% last month).
- Pledged giving for April was \$37,862 (127% of budget versus 95% last month).
- Pledged giving YTD was \$128,612 (108% of budget versus 102% last month).
- Expenses for April were \$41,999 (99% of budget versus 104% last month).
- Expenses YTD were \$170,399 (100% of budget versus 100% last month).
- Net income for April was \$49,422 \$41,999 = \$7,423 (compared to budget amount of -
- \$967)
- Net income YTD was \$164,685 \$170,399 = -\$5,714 (compared to budget amount of -
- \$3.870).
- Calculated reserves were \$125,874 compared to \$118,155 in March (adjusted).

#### Analysis:

- 1. As expected, we saw a financial rebound in April, due to increased giving for Easter. April giving was higher this year than 2022 by about \$6,000. However, year-to-date gross income and net income are well off our pace last year (about \$8,000 and \$20,000, respectively).
- 2. Net income in April was \$7,400, but year-to-date was -\$5,700. Reserves are sitting at \$125,874, about \$6,500 below the reserves entering 2023.
- 3. I feel better about our finances after a stellar month. However, last year's financial performance suggests that we will now be entering several months of flagging revenues. Reserves will likely fall below the desired level of \$100,000 by late summer.

## **Treasurer's Report**

Treasurer's Report – 4/18/2023

Budget Performance (through March 2023):

Gross income for March was \$34,917 (84% of budget versus 71% last month).

Gross income YTD was \$114,967 (92% of budget versus 96% last month).

Pledged giving for March was \$28,212 (95% of budget versus 71% last month).

Pledged giving YTD was \$90,750 (102% of budget versus 105% last month).

Expenses for March were \$44,228 (104% of budget versus 101% last month).

Expenses YTD were \$128,400 (100% of budget versus 96% last month).

Net income for March was 34,917 - 44,228 = -9,311 (compared to budget amount of 967).

Net income YTD was \$114,967 - \$128,400 = -\$13,433 (compared to budget amount of -\$2,902).

Calculated reserves were \$120,445 compared to \$132,144 in February.

- 1. As expected, there was a financial rebound from the poor showing in February. However, all financial indicators were still negative.
- 2. Pledged giving for March was somewhat below budget, but year-to-date is above budget. Gross income in March was only 84% of budget due to worse-than-expected receipts in all giving categories including envelope non-pledged, loose plate, miscellaneous, and special general giving (LCO). Year-to-date gross income is \$10,000 below budget due to low envelope non-pledged giving and miscellaneous giving. Year-to-date loose plate and special general giving (LCO) are hovering around budget.
- 3. Total expenses in March were somewhat above budget with year-to-date expenses at budget. The excess expenses in March were largely due to a three-payroll month.
- 4. Net income in March was down \$9,300 (\$8.300 below budget) and was down year-to-date \$13,400 (\$10,500 below budget). Reserves are sitting at \$120,445, about \$14,000 below the reserves entering 2023.
- 5. The financial trends are not looking promising. The problem is flagging revenues, particularly in envelope non-pledged, loose plate, and miscellaneous. We may also be seeing the beginning of a problem with special general giving (LCO). We are almost \$14,000 behind year-to-date giving at this point last year; when we set the 2023 budget we were expecting higher giving, not lower, due to a big jump in pledges.

#### What

Proposal to extend the hours of the Mount Cross Child Development Center to 5:00 pm

beginning this fall (August 2023).

Current hours are until 3:30 pm. The school has been doing hours until 3:30 pm since September 2022. Currently 30% of our enrolled kids stay until 3:30 pm – all of which would likely extend until 5:00 pm.

#### Why

It meets the needs of current church and school families and it will help to mitigate the loss in enrollment expected by free, public TK. We have missed serving our own communities needs by not having extended hours for working families. We have current families at the CDC who have expressed interest in longer hours. We also have families who are church members who do not attend our preschool because the preschool hours do not meet their needs. We estimate that extending the hours would allow another 20% of students to stay for aftercare.

#### How

The CDC would like to extend hours as a pilot program and review with Council in January.

Per licensing regulations, only those fingerprinted by the CDC can have access to the children, i.e. be behind the fence.

- a. The preference will always be not to have overlap of facility use between CDC and church. Encourage church groups to use the sanctuary or pavilion.
- b. In the case of unavoidable overlap it will be made clear that adults are only to use the bathroom in the church office and each group will have at least one CDC finger-printed volunteer or staff in attendance to insure separation from the children and escort non-fingerprinted adults when walking behind the fenced perimeter.
- c. From 3:30 pm to 5:00 pm the CDC will use Luther Hall and the bathrooms. Children and staff will access bathrooms via the front school entrance 102 Camino Esplendido,

Camarillo, CA 93010 • 805-482-9706 • mountcrosscdc.com behind the fenced perimeter. This leaves the PLC and kitchen (connected via the nursery) for church use.

d. In the rare event of a special occasion (e.g. funeral) that cannot be scheduled at another time, and where access to the bathrooms is necessary, the CDC/church will position a finger-printed staff member or volunteer at the bathroom door to make sure adults are not in the restrooms when children are present and that adults do not wander through the CDC. Alternatively, the CDC may close early (with sufficient notice) to accommodate the church event.

## **Pastor's Report for March Church Council Meeting**

February 11, 2023 – March 20, 2023

- The new Church Council and other interested members met on Saturday, February 12 for the annual Leadership Retreat. I think the gathering was productive and energizing. We are blessed with skilled and engaged leaders. We focused on Reconciling in Christ, re-imagining our committee structure, how to communicate the energy centers we are experiencing at Mount Cross, and the gift policy. Thank you to all who helped plan the day, those who attended, and those who provided the lunch.
- I hosted Collegium (clergy from the ELCA Channel Islands Conference) at Mount Cross in the sanctuary on Feb. 16.
- February 19 was a joyful worship service. It was Transfiguration Sunday. We had baptisms and welcomed new members.
- Ash Wednesday on Feb. 26 at St. Columba's Episcopal Church was a combined service with three churches – Mount Cross, St. Columba's, and Camarillo United Methodist. 160 people attended the service and all three churches appreciated the opportunity to gather together for the start of this holy season.
- On Feb.28, I conducted Joe Zimmerly's Annual Ministry Review, along with the

in-coming and out-going chairs of Family Faith Formation. We celebrated Joe's contributions to ministry at Mount Cross and discussed ways we could increase collaboration to further the ministry.



• LENT: Our Lenten theme and programs were off to a good start with Wednesday programs including *Life Transformed: The Way of Love in Lent* for adults and Fun with Faith for kids at 5 p.m. Soup Supper at 6 p.m. and Holden Evening Prayer at 7 p.m. The messages at Holden are focusing on the "energy centers" at Mount Cross. Jeffrey Saner gave the message on March 1, focusing on his involvement with Music Ministry. The focus on March 8 was Service and Missions and Peace and Justice, with a representative from Lutheran Immigration and Refugee Services speaking. We had a COVID hiatus March 15, but are looking forward to hearing from Cy Johnson about Property on March 22 and Evonne Kuchera about Senior Ministry on March 29. Family Faith Formation will

produce a video message sometime in the next few months.

- Sundays in Lent, I have been weaving the theme of SEEKING and asking honest
  questions into my sermons. Kevin O'Farrell and I are team-teaching an adult forum
  class on Sundays from 11-Noon called "Christianity Through a Lutheran Lens." We are
  using Daniel Erlander's *Baptized We Live* booklet. The class is well-attended and
  people are reporting that they are finding it meaningful.
- For the Episcopal Diocese of Los Angeles, I helped plan our first ever Diocesan Information Gathering for people considering God's call in their lives. Over 80 people attended the event in Echo Park on March 4. As part of the program, I led a group discernment exercise.
- With sadness and grief, as well as hope and gratitude, we said goodbye to beloved Mount Cross member, Pat Dawson, on March 4.
- I was interviewed by Tim McDonell March 8 about my experience with the *Interfaith Friendship Project*. He and Tim Helton will be presenting about it at the World Parliament of Religions this summer.
- Staff COVID infections, including my own, canceled on-site programs, meetings, and worship from March 13-March 19, but Joe, Carol, and I have been able to work from home. I am thankful for the care and prayers extended to all of us, and for the wise leadership of our President, Bill Stoll.
- I met on Zoom March 14 with the pastors from Camarillo UMC and St. Columba's to finalize plans for combined Holy Week services. See below for our Holy Week plans. I hope Council members will attend as many services as possible.



We were able to raise over \$230.00 towards our high school youth summer trip to the Western States Youth Gathering at Cal Lutheran. The continuous support from the congregation means so much to our youth and all involved in our programs.

On March 11th, our high school youth were invited to play Broomball with other youth groups from the area. We gathered at the Simi Valley Iceoplex from 9:15pm - 10:45pm for great community time. We look forward to gathering with these same youth groups in June for Midnight Madness.

Looking ahead, we are excited to have our annual Easter Breakfast and Egg Hunt. Our high schoolers will be cooking pancakes and sausage served with fruit, coffee, juice, etc. We are collecting a free will offering where all the proceeds will go towards our high school summer trip.



## **Treasurer's Report**

#### 3/21/2023

## Budget Performance (through February 2023):

Gross income for February was \$29,568 (71% of budget versus 121% last month).

Gross income YTD was \$80,050 (96% of budget versus 121% last month).

Pledged giving for February was \$21,217 (71% of budget versus 139% last month).

Pledged giving YTD was \$62,538 (105% of budget versus 139% last month).

Expenses for February were \$42,896 (101% of budget versus 91% last month).

Expenses YTD were \$81,785 (96% of budget versus 91% last month).

Net income for February was \$29,568 - \$42,896 = -\$13,328 (compared to budget amount of - \$959).

Net income YTD was \$80,050 - \$81,785 = -\$1,735 (compared to budget amount of \$1,918).

Calculated reserves were \$132,144 compared to \$145,471 in January.

#### Analysis:

- 1. Pledged giving and gross income were much higher than projected in January, similar to last year. This is likely due to prepayment of annual pledges and carryover from holiday giving. And similar to last year, pledged giving and gross income plummeted in February.
- 2. Expenditures for February were 101% of budget, and YTD expenditures were 96% of budget.
- 3. Net income in February was way below budget, balancing out January's favorable results. For the time being, net income YTD is on budget.
- 4. Reserves are sitting at \$132,144, slightly below the reserves entering 2023.
- 5. Thus far in 2023, gross income is running \$11,000 behind last year and \$3,000 under budget. If these trends continue throughout the year, we will spend much more of our reserves than had been anticipated. Next month's financial results will help clarify the extent of our problems.

WHAT: This is a "soft space" in a corner of the church - basically a rocking chair or two, some blankets or cushions, soft rug, and maybe some ground small chairs for children that provides a comfortable place for little children to experience. See a few pictures below.

WHY: This helps carry out our mission of inclusivity and being a welcoming place for families and little ones to grow their faith. This does not negate the need for a nursery or Children's Church; rather it supplements our existing spaces and programs.

WHERE: We will run a pilot of the Prayground concept on the carpeted area on the far left side of the sanctuary.

WHO: This space is for young children (primarily babies and toddlers, at least to start) and their families - or anyone who would like to experience the service in a soft space corner of the church.


WHEN: Our plan is to start the pilot in April after Easter Sunday in time for our next play date Sunday (April 30). We can run the pilot through the summer and solicit feedback and input on what worked well, what didn't, and what would we like to adjust.

HOW: Joe has already secured a Thrivent Action Team grant to purchase the bigger items and have been collecting donated items for the space. Amanda Honda and Joe have been taking the lead to pull this together, leveraging gently used items from other church families or the local community. They are planning to use materials and items that naturally blend into the space.

We are so thankful for camp being able to provide safe and brave spaces for our kids to question and explore.

Sunday February 12th is our second Serving Sunday - Family Edition where we will have members from 9 different households participating in worship. Whether it is acolyting, communion assisting, reading, etc. we are glad to have our kids and families serving. Afterwards, all are invited to participate in our B.Y.O.B.... Bring Your Own Barbeque at the church!

In February, we are looking at assembling a youth council. This is a small youth leadership group I will be looking to form with representation from all ages. The purpose of this youth council will be to develop their leadership skills. I look forward to reporting back my progress with this project.

## Property Committee Recommendation to Church Council Regarding Sanctuary Stucco Repair February 6, 2023

At long last, the Property Committee arrived at a recommendation to Church Council for action on a remedy for the discolored slopes on the exterior of the sanctuary. That recommendation is to accept the October 2022 Preliminary Estimate by Kenstruction Inc. for covering the slopes with flat terra-cota roofing tile at the price of \$14,753.

The scope of work leaves the existing stucco on the slopes and calls for installation of new sheet metal flashing to shed water onto a new underlayment installed on top of the existing stucco and then the new roofing tile. The new tile will: a) not show dirt so readily; b) provide an additional layer of waterproofing and; c) provide a durable surface. A copy of the proposal is attached to this recommendation.

#### Discussion:

As Council Members may be aware, the Property Committee made extensive inquiries into the options for treating the slopes and talked to eight contractors. Four visited the site and received plan copies. Two of them excused themselves from bidding citing lack of staff or long backlogs of work. Two offered ballpark quotes but never progressed to firm bids despite pleas to do so. Two, including Kenstruction, Inc. provided written proposals. Committee members weighed recommendations against each other for logic and practicality.

Conversations with roofers revealed a reluctance to do more than the simple roof application without the involvement of a general contractor to do the preliminary demolition and installation of flashings. One plasterer was confident that a solution based on specialized priming and epoxy plaster material would solve the problem but at a cost approximating \$30,000. G Daniels Construction quoted \$23,335. One general contractor suggested covering the slopes with flat sheet metal. Another recommended ribbed factory-painted sheet metal roofing. For reasons of aesthetics and cost these options were rejected. This narrative is a distillation of several dozen phone calls, emails and meetings over eight months.

This recommendation was further delayed while time was spent testing the effectiveness of pressure washing some slopes in early December. After seeing the relative success of pressure-washing some of the slopes, Kenstruction was asked to provide an alternate price for completing the pressure washing of the slopes and repainting them with elastomeric paint at a cost of \$10,294 plus \$89 for each instance where a gouge in the stucco requires patching (leaving an unknown scope and cost).

Budget Performance (through December/Year-End 2022):

Gross income for December was \$40,849 (111% of budget versus 99% last month).

Gross income for 2022 was \$466,304 (105% of budget).

Pledged giving for December was \$25,878 (100% of budget versus 100% last month).

Pledged giving for 2022 was \$334,089 (108% of budget).

Expenses for December were \$40,326 (99% of budget versus 105% last month).

Expenses for 2022 were \$497,529 (101.5 % of budget amount of \$490,347).

Net income for December was \$40,849 - \$40,326 = \$523 (compared to budget amount of - \$3.994).

Net income for 2022 was \$466,304 - \$497,529 = -\$31,225 (compared to budget amount of -\$47,927).

Calculated reserves in December/Year-End were \$134,655 compared to \$135,736 in November.

## Analysis:

- 1. The financials finished strong in December, due to holiday giving.
- 2. For the year, pledged giving and income were well above budget. Expenses were \$7,000 higher than budget in 2022 (101.5%) due to higher insurance costs, unbudgeted payment of CDC incorporation fees, unplanned installation of a new HVAC system, and higher worship and music costs.
- 3. The annual loss for 2022 was \$31,225 compared to the budgeted loss of \$47,927. Reserves were down by over \$31,000 in keeping with the annual loss. Despite this loss, reserves continue to be in the healthy range above \$100,000.
- 4. The perpetual fund designated for property and capital improvements is now over \$32,000 due to a generous gift of \$15,000.

## **Letter from Personnel Committee**

California law changed effective 1/1/23 to require that employers with at least 5 employees to provide at least 5 days off when a "Family Member" dies. AB1949

• The Personnel Committee moves to make the following change to the Employee Handbook to come into compliance with the new law:

## **Bereavement Leave**

Employees who have been employed for at least 30 days before the start of leave are eligible for five (5) days of bereavement leave for the death of a family member, as defined below. Bereavement leave must be completed within three months of the family member's date of death, although the days do not need to be consecutive.

The first two (2) days of leave will be paid leave and any additional days shall be unpaid. Employees may use accrued but unused vacation or sick leave to substitute for any unpaid bereavement leave or if additional time is granted. Additional unpaid time off may be granted at the discretion of the employee's supervisor on a case-by-case basis.

For purposes of this policy, a family member includes an employee's: Spouse or domestic partner; Parent, including a step-parent and parent-in-law; Child, including a step-child and child of a domestic partner; Sibling; Grandparent; Grandchild; Mother-, Father-, Sister-, Brother-, Son-, or Daughter-in-law. Parent and child relationships include step, foster, and adopted relationships, and relationships based on one individual's legal guardianship or *in loco parentis* relationship to another.

Employees are responsible for requesting bereavement leave from their supervisor as far in advance as possible. Mount Cross may require verification in the form of a death certificate, obituary, or other verifiable documentation of the need for bereavement leave.
