• Action: Motion from Personnel Committee regarding change to vacation policy

#### Health Insurance Reimbursement.

The Employee Handbook be modified so that part-time employees who regularly work more than 30 hours per workweek be granted 1 week of paid vacation; and that the handbook be clarified that all other part-time employees can take unpaid vacation leave if approved by the Pastor. The amendment utilizes the following language

The first paragraph of the Vacation Leave policy in the Employee Handbook, at page 11, to read as follows:

<u>Vacation Leave</u>. Mount Cross grants ten (10) days paid vacation to full-time employees working 1-5 years. After 5 years of employment, full-time employees will earn one additional day of paid vacation for each year of service up to a maximum of 15 days' vacation. <u>Mount Cross grants to any part=time employee</u> <u>who regularly works more than 30 hours per workweek five (5) paid vacation</u> <u>days at their regular rate of pay for the number of hours that would normally have</u> <u>been worked</u>. Vacation accrual begins upon employment in a position eligible for vacation benefits and is earned pro-rata from their start date. For example, an employee starting on July 1, would be eligible for one half the normal vacation time earned for their credited experience. Overtime hours are not included in the basis for calculating vacation accrual. Vacation must be scheduled at a time appropriate to the planning of the organization and approved in advance by the Senior Pastor.

Call for the question by Bill Stoll, the motion passed.

• Action: Motion from Personnel Committee regarding change to the Health Insurance Policy

The motion from the Personnel Committee was: That the Employee Handbook be modified to offer all full-time salaried employees \$200 per month toward the purchase of an individual health policy. This benefit would only be a reimbursement of the employee's purchase of health coverage effective January 1, 2022.

A Motion to modify by Brian Fisher as follows:

All Exempt employees as defined above are eligible to receive a partial reimbursement for the cost of health insurance. In order to receive this benefit the employee must submit to the Treasurer proof that a health insurance policy covering the employee has been purchased and is in effect during the period of reimbursement.

The amended motion passed.

8. Treasurer/bookkeeper will presort auditor selected month files as requested for more efficient performance of the internal audit.

## Treasurer's Report – 4/20/2021

**Approval of Minutes for January 12, 2021:** Motion to approve the minutes by Keith Selbrede, second by Herb Holler. The minutes were approved.

Listening Post: There was no listening post report

## **Committee and Staff Reports**

<u>Pastor Julie</u> provided a written report in the form of a pie chart showing her time divided in worship, 30%, Administration 30%, Pastoral Care 20%, Education 14%, and wider church and community including the ELCA Synod & Episcopal Diocese 6%.

She also brought a motion from the worship and music committee to proceed with the search and hiring process of a temporary music director. The temporary position will combine what was 3 positions—choir director, bell choir director and praise band director. The proposal is for the position to remain temporary through the fiscal year to January of 2022. The motion passed.

Ash Wednesday services will be available tomorrow at 7 am, noon and 7pm. Ashes have been mailed out to the congregation.

<u>Joe Zimmerly</u> provided a written report. Excited about 2 new council representatives and assistants (unpaid), interns from Cal Lutheran He is hoping to introduce them next week.

They are starting small groups which are to be community building experiences driven by faith. He hopes to launch the program on the March 8<sup>th</sup>. He is looking for members of the congregation to be group leaders.

Keith Selbrede provided a written financial report. Financials are posted on the website.

Budget Performance (through January 2021):

Gross income for January was 117% of budget. Pledge giving for January was 119% of budget. Expenses YTD were 80.3% of budget. Calculated reserves were \$180,636 compared to \$115,518 the end of 2020. This was due to the Episcopal Diocese getting their PPP loan resolved so we received a reduction in our 2020 bill of nearly \$40,000 plus the above reported giving/expense results for January.

Craig Blois mentioned the need to look at investments, for our significant checkbook balance and Keith committed to having the Budget and Finance committee make recommendation(s).

Susan Prosser reported for the Care Team: About to start the second round of annual check-in calls to the congregation. She asked for input from the council regarding the information to impart as well as specific questions about needs. Last year there were 13 or 14 callers to divide up the directory for calls. Kristine Dawson and Becky Riley volunteered.

<u>Bill Stoll reported for the Peace & Justice Committee</u>: They want the Council to renew its pledge, engage in education and training for the council and have individual Church members also take the pledge. Beginning in March they will begin an education program for church members including a zoom discussion.

The Peace and Justice Team and Service and Missions Committee made a motion that Council continue to build upon the work of our last Council; that we renew and re-sign our pledge and lead our congregation to become an anti-racist congregation.

The motion was tabled until our next meeting.

<u>Barbara Cranfill reported for the Stewardship Committee:</u> Barbara thanked Susan Prosser for her leadership on this committee and said that she hopes there will be additional volunteers as the committee only consists of 3 people.

Susan Prosser provided written information regarding the CDC task force regarding sustainability. It is a 14-member task force. She pointed out some possible congregational issues regarding extending the time that the CDC might need to use the Church facilities in order to remain financially sustainable.

Joe Zimmerly pointed out that they have been meeting every week with 3 separate groups each of which has brought ideas and questions.

It was agreed that further information is needed but that these are important issues of which the council needs to be aware and giving thought.

# Pastor Julie requested that we have a report from the task force by the next meeting.

<u>Committee Liaisons</u>: Each council person described the duties of the committees on which they serve as liaisons. Both the Property Committee and the Welcome Team are without liaisons.

Kris Dawson volunteered to be the liaison to the Welcome Team and John Marroquin volunteered to be the liaison to the Property Committee.

All other council members will remain as liaison to the committee they were with last year.

## **Committee and Staff Reports:**

<u>Pastor Julie</u> provided a written report. Most involved in the Christmas season worship services and house blessings. We welcomed 5 new members to Mount Cross: Bruce and Peggy Stevenson, Jody Devere, and Karin & John Grennan.

There was a, <u>motion by Bill Stoll seconded by Susan Prosser</u>, to approve the application of the new members. The motion was approved and there was discussion of connecting the new members with sponsors.

The proposed 2021 budget will be in written form at drive-through communion as well as a link in the e-grapevine.

Joe Zimmerly provided a written report. There will be family bingo this Sunday.

<u>Craig Blois</u> reported that the CDC task force is in progress and seems to be a good mix of members of Mt. Cross and CDC.

<u>Keith Selbrede</u> provided a written financial report. Financials are posted on the website.

Budget Performance (through December, 2020):

Gross income for 2020 was 103.6% of budget, up from 96% the end of November.

Gross income for December was 144% of budget up from 96.8% in November.

Pledged giving YTD was 102% of budget, up from 99.2% the end of November.

Pledge giving for December was 133% of budget.

Expenses YTD were 91.3% of budget.

December expenses were 92.1% of budget.

Calculated reserves were \$139,518 up from \$128,336 last month.

Other Items:

2021 Requested Budget is ready for council to amend/recommend for congregation approval.

<u>Barbara Cranfill</u> reported for the Stewardship Committee that Thank You notes will be sent out tomorrow for people's contributions of time, talent and pledges.

<u>Craig Blois reported for the Re-opening Committee:</u> The Committee brings a Recommendation that we find ways to scale back. For the next month—no person in attendance at services other than participants. We will continue to have drive-through communion. The in-office staff is to work from home as much

as possible. The County is at 58 new COVID cases per 100,000 people which is about 7 times the level to be in the red tier.

Pastor Julie will call the people who have been coming to services in person but the committee will send a letter to the whole church.

The process of counting donations can still include 2 people as long as they are masked and at opposite ends of a long table.

As to the CDC, there have been no COVID cases on the CDC campus and they have a policy and procedure which seems to be working. For now, we are allowing them to continue. We need to have a conversation with Cathy particularly regarding sanitizing.

Wendy McClary said that they have a written protocol and the board is doing random checks and so far they seem to be doing a good job.

<u>Bill Stoll called for the question on the recommendation and the recommendation passed.</u>

A slate of candidates will be e-mailed to the council.

<u>There was a Recommendation from the Personnel Committee</u> to make amendments to the employee handbook. The amendments were provided via email to the Council. The Recommendation passed.

#### ANNUAL MEETING AND VOTING FORMAT

It was decided that we would hold the discussion portion of the by-law change, but delay the vote and collect votes on a later date. We will collect the votes as written ballots. Attendance must be taken and each person must deliver their own ballot. The name will have to be checked off against the list of persons who were in attendance at the meeting.

There was a motion by Brian Fisher, seconded by Keith Selbrede that any vote that cannot be taken by acclimation will be included on a secret ballot to be distributed and returned at a later date.

At 9:01, there was a <u>motion by Bill Stoll seconded by Allison Johnson</u> to extend the meeting beyond 9:00. The motion passed.

#### Keith Selbrede Presented the Requested Budget

Summary of 2021 Requested Budget

- 1. Projected total income is \$437,329 down from 2020 actual (PPP aided) income of \$499,782.
- 2. Projected pledge income of \$298,065 down from \$354,425 actual in 2020.
- 3. Projected operational expenses of \$479,316 up from \$428,729 actual in 2020.
- 4. Budget comparison breakdown by major category provided for discussion.

As the requested budget was not balance, there was a recommendation to include a Good Faith Offering in order to balance the budget. There was then a Motion by Bill Stoll seconded by Allison Johnson to approve the recommended budget using a Good Faith Offering line to balance the budget. After discussion, the motion passed.
